Company Background



Simm Samm Hotels Private Limited (SSHPL) was incorporated on December 14, 2005. SSHPL is a private unlisted company.

SSHPL is promoted by Mr. Shamme Swaran Salaria and Mrs. Santoshkaur Swaran Salaria.

The business of SSHPL is focused on the hospitality sector and its key operating hotel assets are as follows:

- 1. The White Hotel at Katra, Jammu & Kashmir Hotel at Katra is a 4-star operating property with a room inventory of 196 and is located at Katra-Reasi Road which is 48 km from Jammu Airport.
- 2. Hotel Project at Mumbai, Maharashtra Proposed Hotel at Mumbai is fully constructed, non-operational with a room inventory 214. The hotel property is located at Sahar Road, Andheri (East) at a distance of 2 km from Mumbai International Airport. The hotel property was constructed in 2017, however, due to the dispute with regard to the ownership of land with Maharashtra Government, it could not be commissioned and is currently non-operational with no requisite approvals.

The authorized capital of the Company is Rs.10 Crore and paid-up capital is Rs.9.63 Crore, present shareholding of SSHPL is as follows:

- The White Hotel, Katra is pioneer premium hotel in Katra, however, many premium and well-known brands have started or planning to start their operations in the vicinity which includes ITC, Vivanta, Sarovar Portico, Lemon Tree, Ramada, Ginger, Holiday Inn, etc. This has impacted the business of the hotel resulting into poor occupancy and lesser revenue.
- Operations of the hotel has been transferred to the proprietorship firm of Mr. Shammee Salaria, namely, The White Hotels, from February 16, 2023, for a period of 16 years at rent @ 2% of Net Profit (After EBIT) or minimum of Rs.1,00,000 per month, payable half-yearly
- The White Hotels is a member of Radisson Individuals, however, the details of the contract is yet to be shared by the erstwhile management.
- There were around 120 employees who were managing and operating the property. The employees have been transferred to The White Hotels and The White Hotels is making the payments to these employees post February 2023 and hence none of the employees have filed a claim against the Corporate Debtor.
